Exhibition:

27 April 2017: from 03.00 p.m. to 08.00 p.m.

28 April 2017: from 10.00 a.m. to 08.00 p.m.

29 April 2017: from 10.00 a.m. to 08.00 p.m.

30 April 2017: from 10.00 a.m. to 12.00 p.m.

Entrance for exhibitors: every day one hour before the official opening time. Subject to modification.

5) Registration

The online registration is binding. Due to the invoicing process and preparatory organisational issues, online registrations are only possible until April 12th, 2017. An entry in the Guide (official participants' index) can only be guaranteed if the registration is submitted before March 17th, 2017. Registrations that are submitted after this date cannot be listed in the print version of the Guide. As of the first day of the event, registrations are also possible on site. A retrospective entry in the online index is possible until July 01st, 2017.

6) Participation fees for professional participants

For early-bird bookings until October 14th, 2016

All walk up registration will be charged with an additional fee of 20€ + 19% VAT.

7) The participation fee for professional participants includes the following services:

Entrance to the exhibition, incl. all showcase concerts and events at exhibition hall 6 & 7 and Kulturzentrum Schlachthof. A personal badge and the official jazzahead! goodie bag with participants' information (handed out on site). An entry in the Guide with all important personal data (online & print) as well as a login to the online database. As a professional participant all days you are now allowed to make a showcase application (deadline October 31st, 2016)

8) Payment/cancellation

Payment is to be made after the issue of the invoice (payable immediately) via bank transfer or credit card. On site cash payment or payment via credit card is possible. A cancellation is free of charge until two weeks after receipt of the registration – later cancellations will be charged with 30% of the registration fee until December 15th 2016. After this date cancellations will be charged with 50% of the registration fee. No-shows will be handled like cancellations. Cancellations must be declared in written form. A substitute participant can be accepted in case the registered participant is unable to attend. The name of the substitute person has to be submitted by March 17th, 2017 in written form.

In case of force majeure, the General Participation Directives of the IDFA members (a partnership of German fair and exhibition cities) dated 2009 apply. In these cases, in addition to paragraph 8.2, MESSE BREMEN retains 20% of the total registration fee for the costs incurred up to that point.

9) Photo and video

As part of its events, MESSE BREMEN and approved press and TV will take photos and make film, video and TV recordings of the event, trade fair visitors and stands and exhibits. In consideration of the German Law on the Protection of Copyright in Works of Art and Photographs (KUG), the photos and recordings are used gratuitously for media publications and trade fair-related promotion of MESSE BREMEN. If you dissent to this use, please contact our photographers or our exhibition team at the entrances and exits.

10) Data protection

Your personal data will be used exclusively internally and specifically for the completion of our services and your stand booking, and in accordance with the stipulations of the Federal Law on Data Protection (Bundesdatenschutzgesetz). The provision of this data is voluntary. It is, however, required to register for a trade fair stand. The address will be published in the exhibition catalogue. Data will be deleted upon the expiry of the legally required data retention periods.
